BY-LAW NUMBER 544
[As amended by AM B/L 1794-2009]

**BEING A BY-LAW OF THE CITY OF THOMPSON TO REGULATE THE
LICENSING OF LOTTERIES WITHIN THE CITY OF THOMPSON**

WHEREAS pursuant to Order-in Council No. 282/70, The Lieutenant-Governor-in-Council has authorized any Municipality to license any charitable or religious organization located within its boundaries to conduct and manage a raffle lottery, a bingo lottery or a lottery scheme held at a bazaar, as provided in clause (c) or subsection (1) of section 179A of the Criminal Code of Canada, where the total prizes for each raffle lottery or bingo lottery do not exceed the value of Three Thousand (\$3,000.00) Dollars, and each lottery scheme to be held at a bazaar is in accordance with sub-clause (II) of clause (c).

NOW THEREFORE, the Municipal Council of the City of Thompson, enacts as follows:

1. Any charitable or religious organization located within the boundaries of The City of Thompson may be granted a license to conduct and manage a Bingo lottery, a Raffle lottery or a lottery scheme held at a bazaar, as provided in clause (c) of subsection (1) of section 179A of the Criminal Code of Canada, where the total prizes for each such Raffle lottery or Bingo lottery do not exceed the value of Three Thousand (\$3,000.00) Dollars, and each lottery scheme to be held at a bazaar is in accordance with sub-clause (II) of clause (c).
2. Application for licenses as above-described shall be in accordance with or shall be in the form attached hereto as Schedules "A", "B", and "C" to this By-Law.
3. The license shall be in the form attached hereto as Schedule "D" to this By-Law.
4. The financial report of the licensee shall be in the form attached hereto as Schedule "E".
5. No license shall be issued to a charitable or religious organization where;
 - (a) the organization proposes to use the services of a person or organization to conduct and manage the lottery on its behalf, for a fee or other valuable consideration,

- (b) pyramiding of games is to be permitted, or
- (c) games of a type or kind known as razzle dazzle, roll down, three card monte, punch board, coin table or any dice games are to be operated.

- 6. The fees for the issuing of licenses shall be as established in the City of Thompson Fee and Fine Schedule as it exists, or as amended.

- 7. The Municipal Council of the City of Thompson may by resolution appoint a licensing officer who shall be charged with the responsibility for issuing licenses for lotteries within the City of Thompson.
