

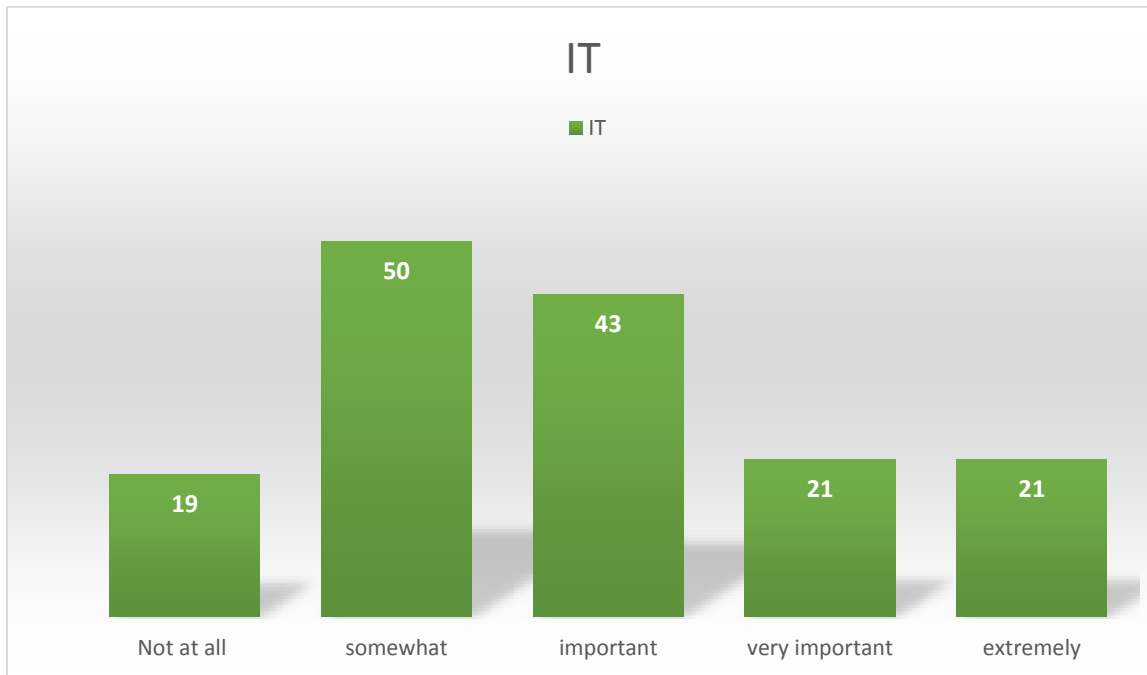

The results for paper and online have been combined below and do not include the employee paper submissions.

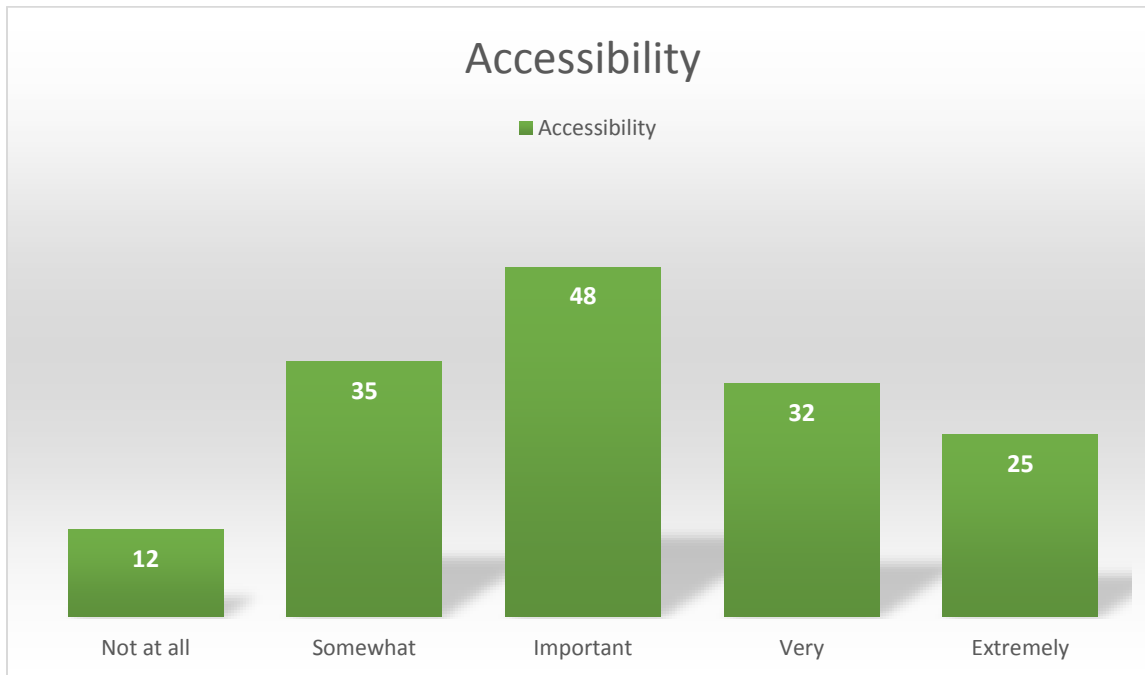

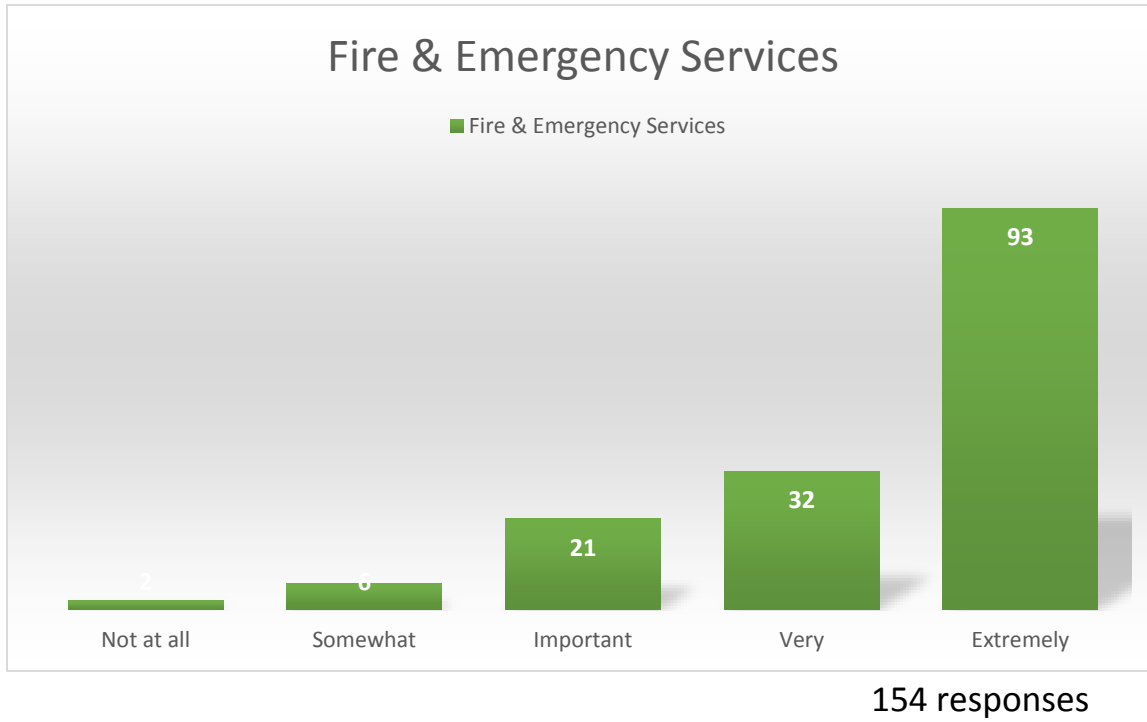
3) Accommodation Tax (5% charged at time of hotel room rental currently used for Infrastructure, Public Safety and Affordable Housing)



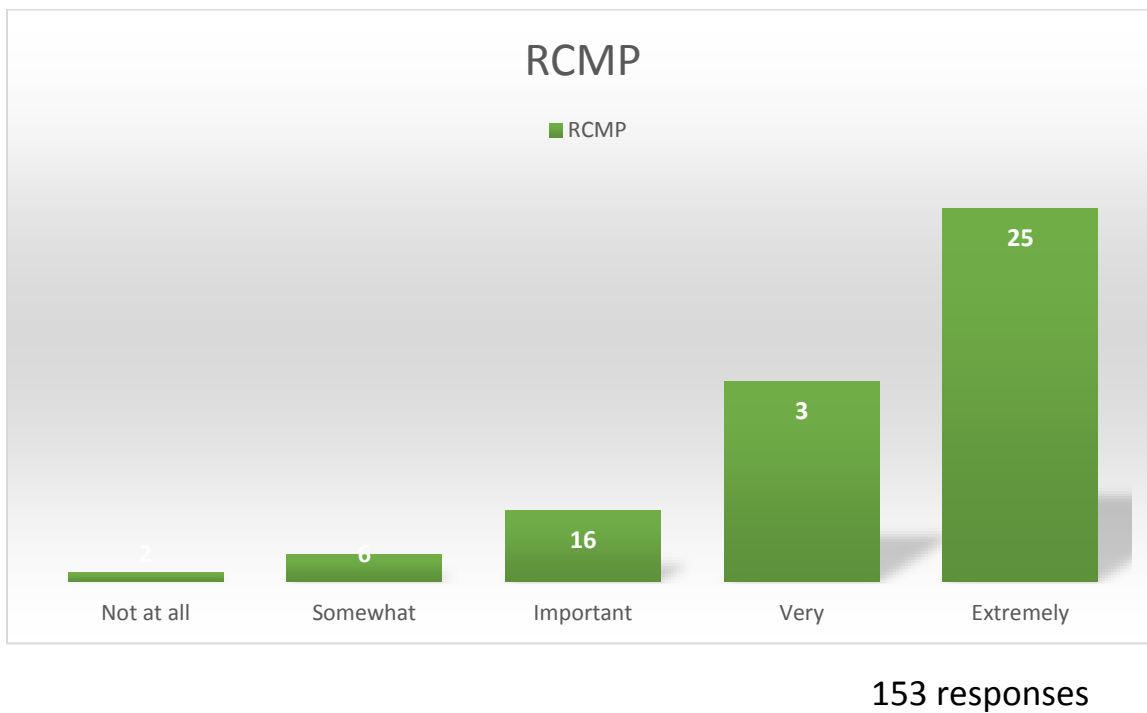

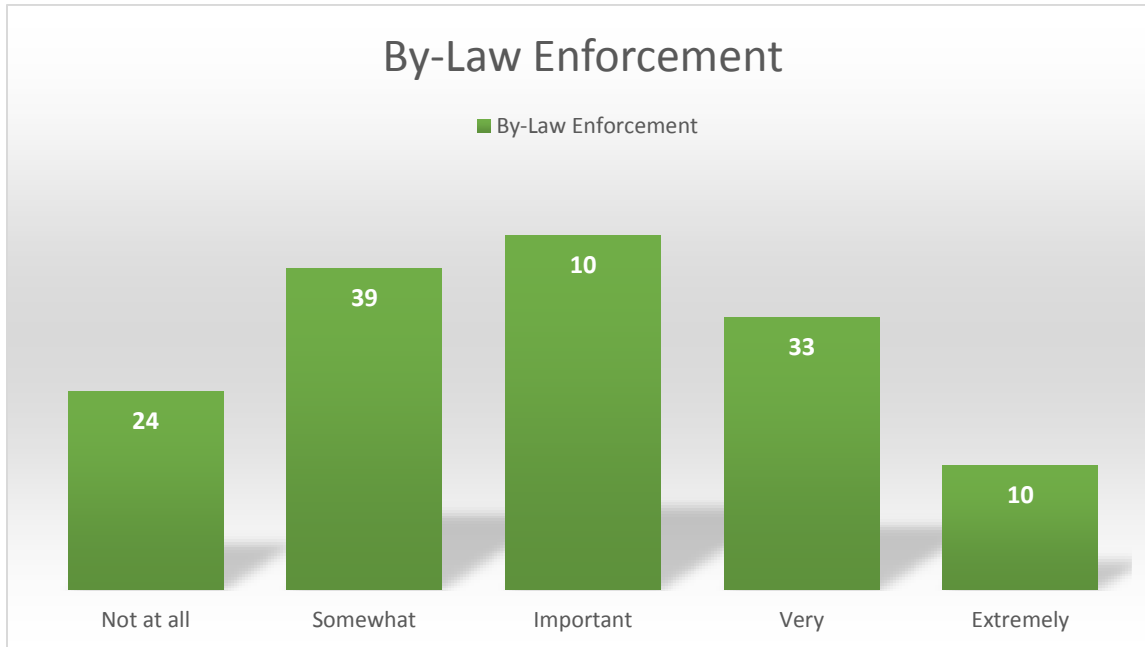

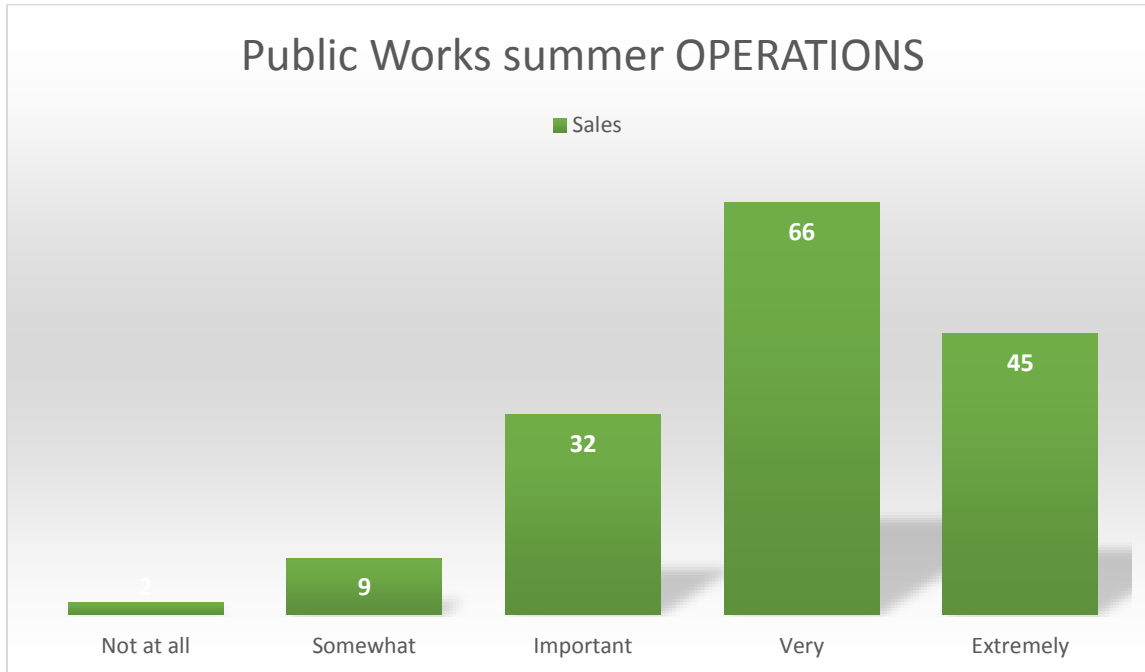

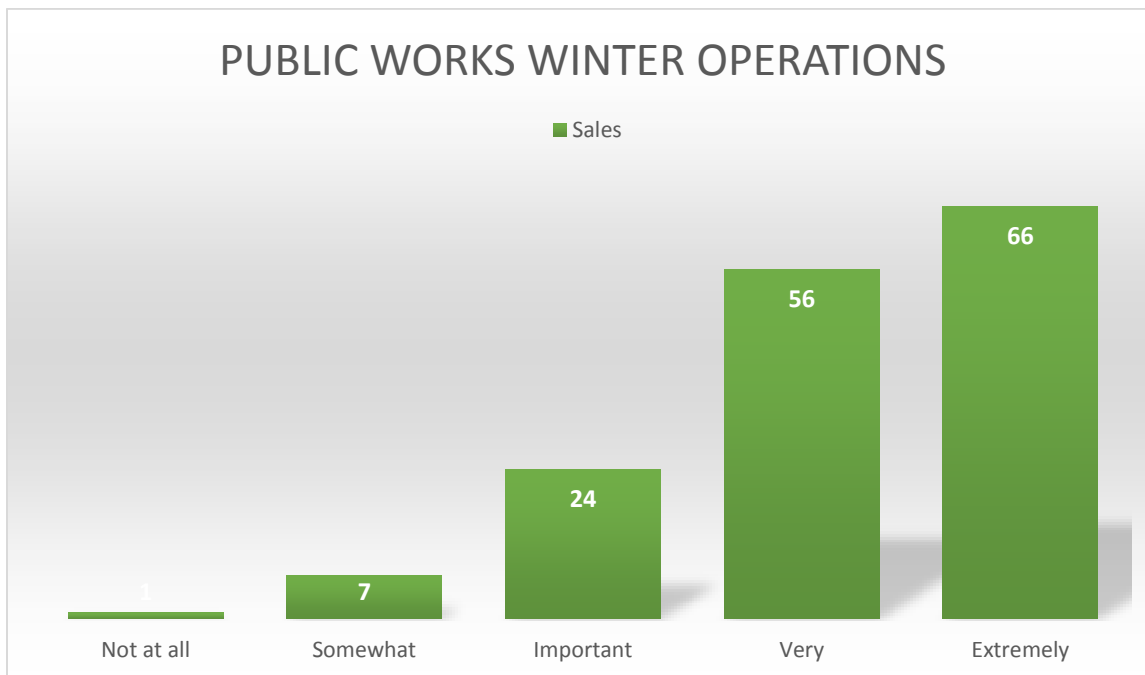

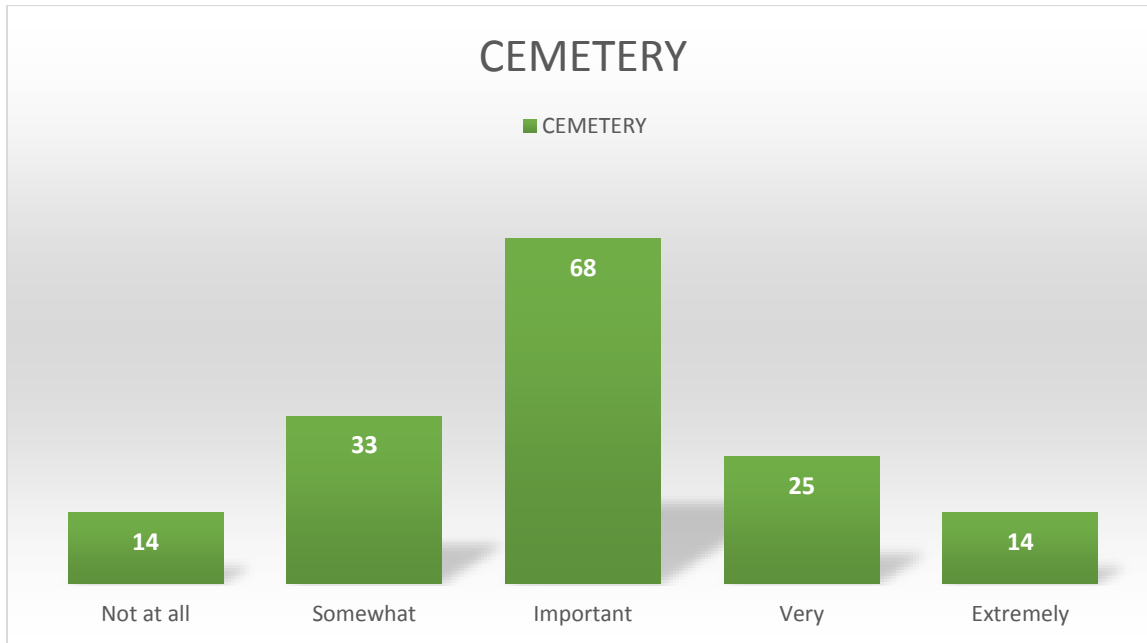

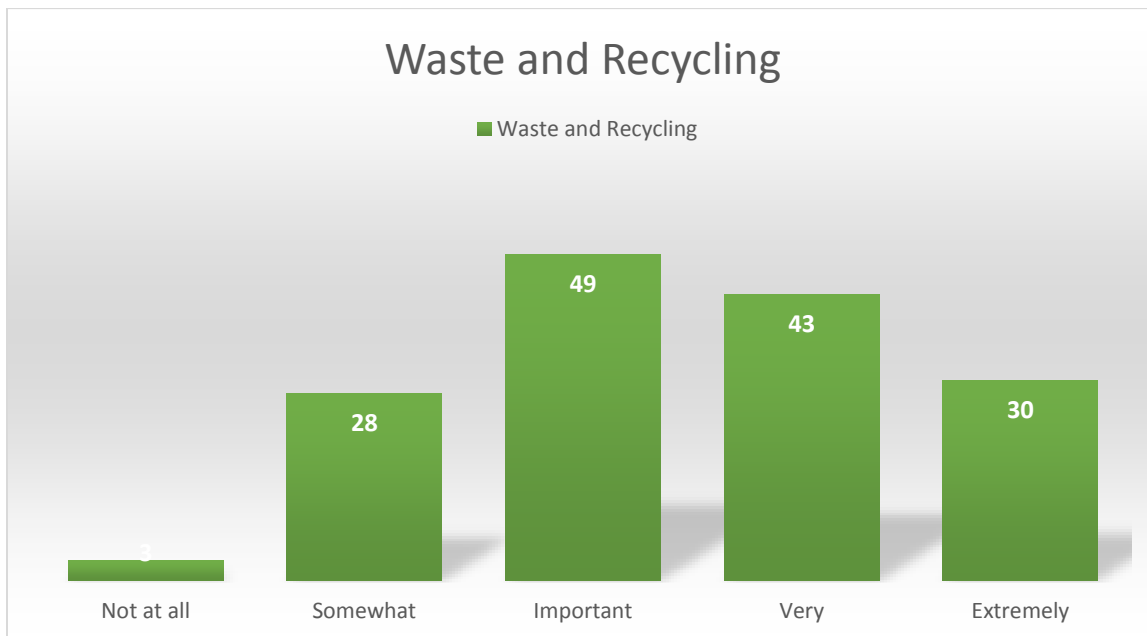

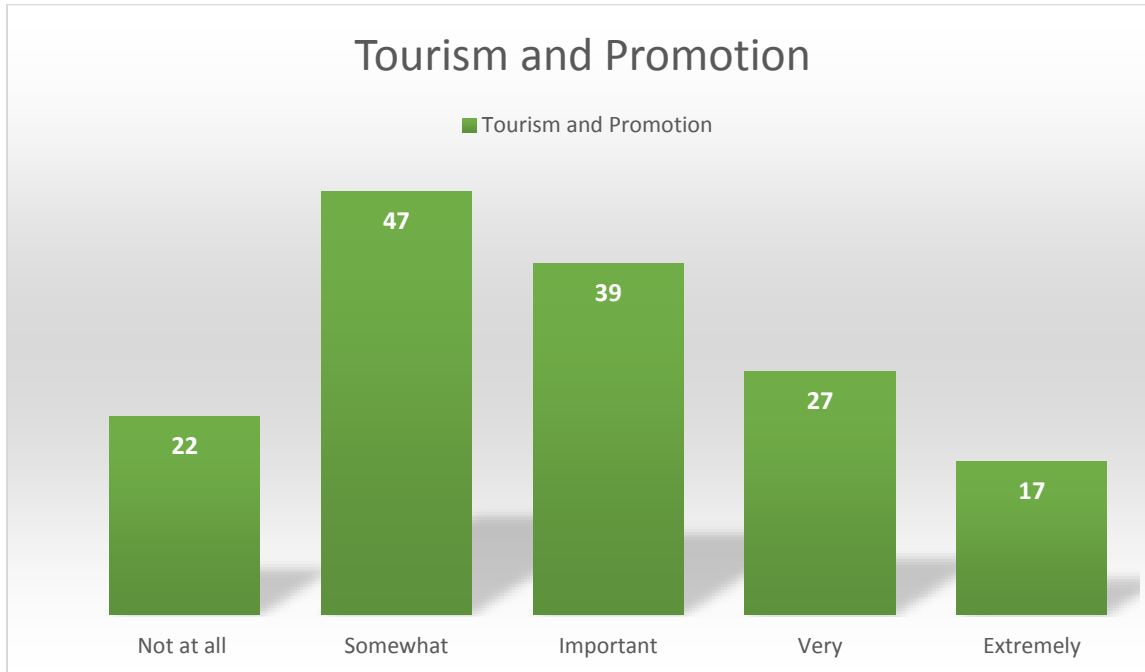

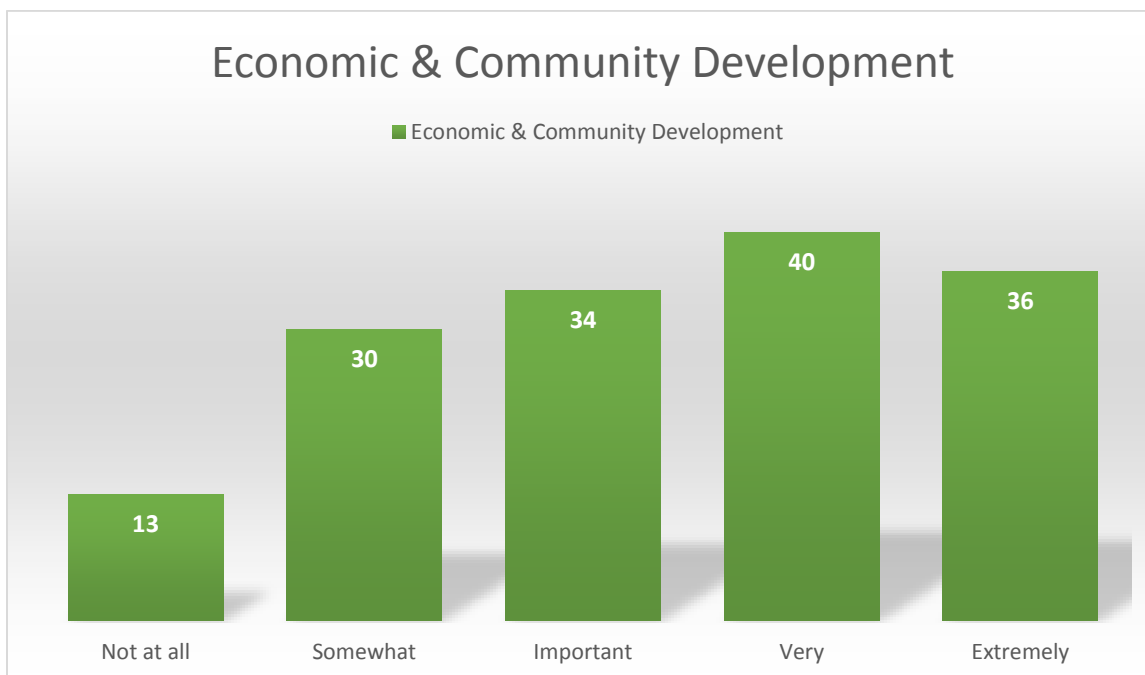

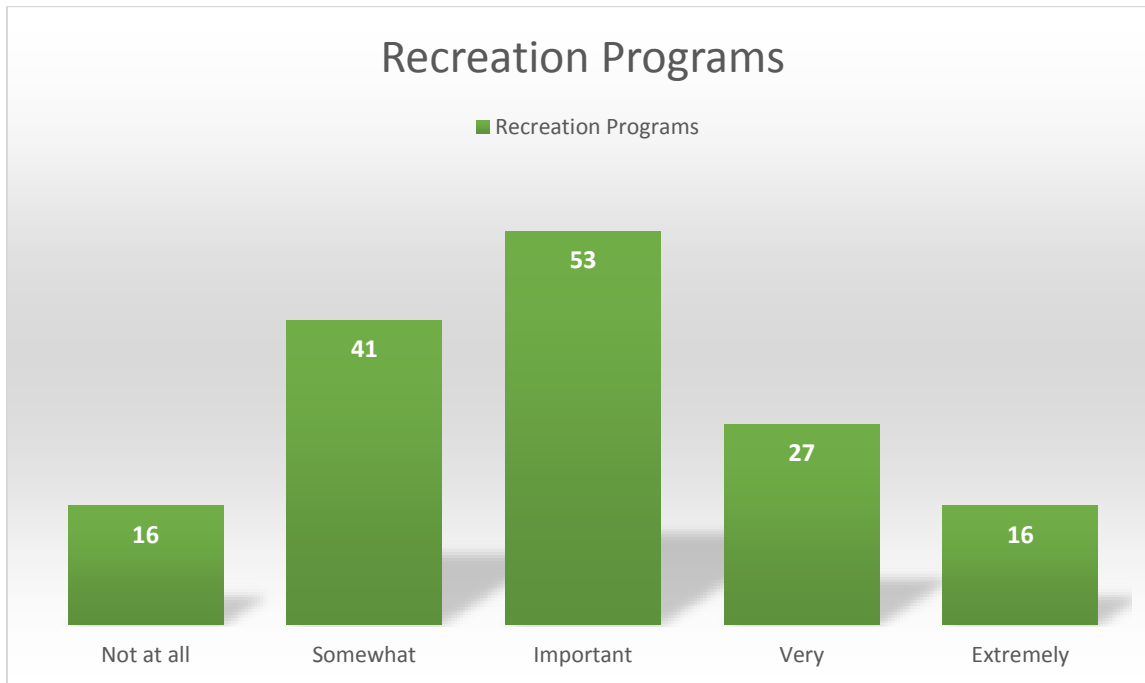

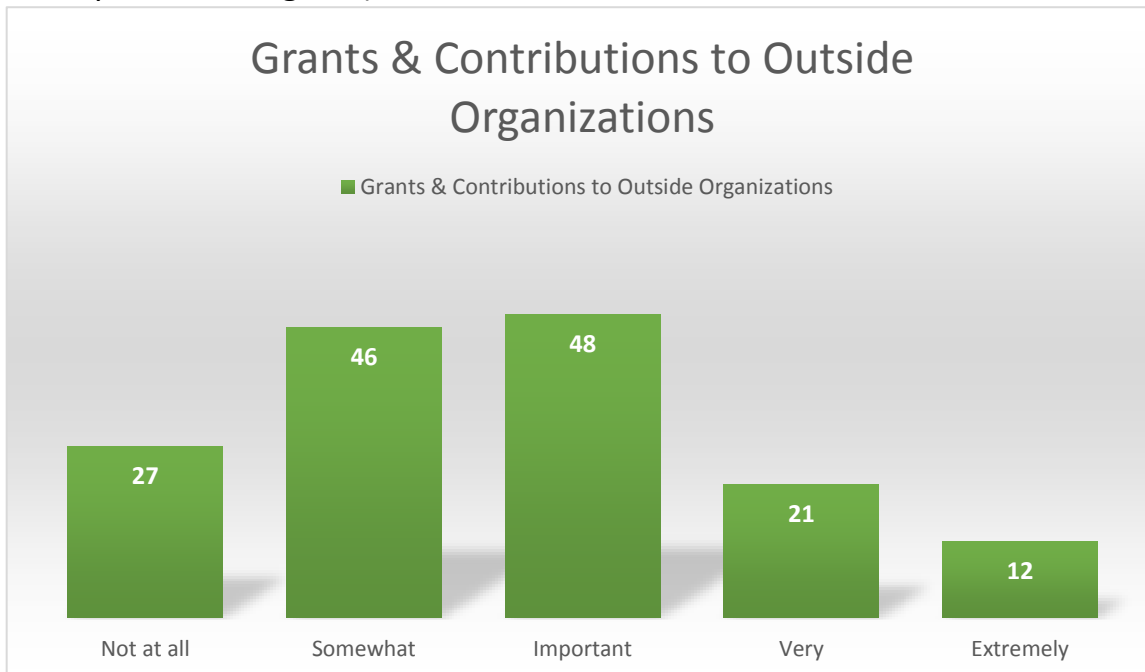

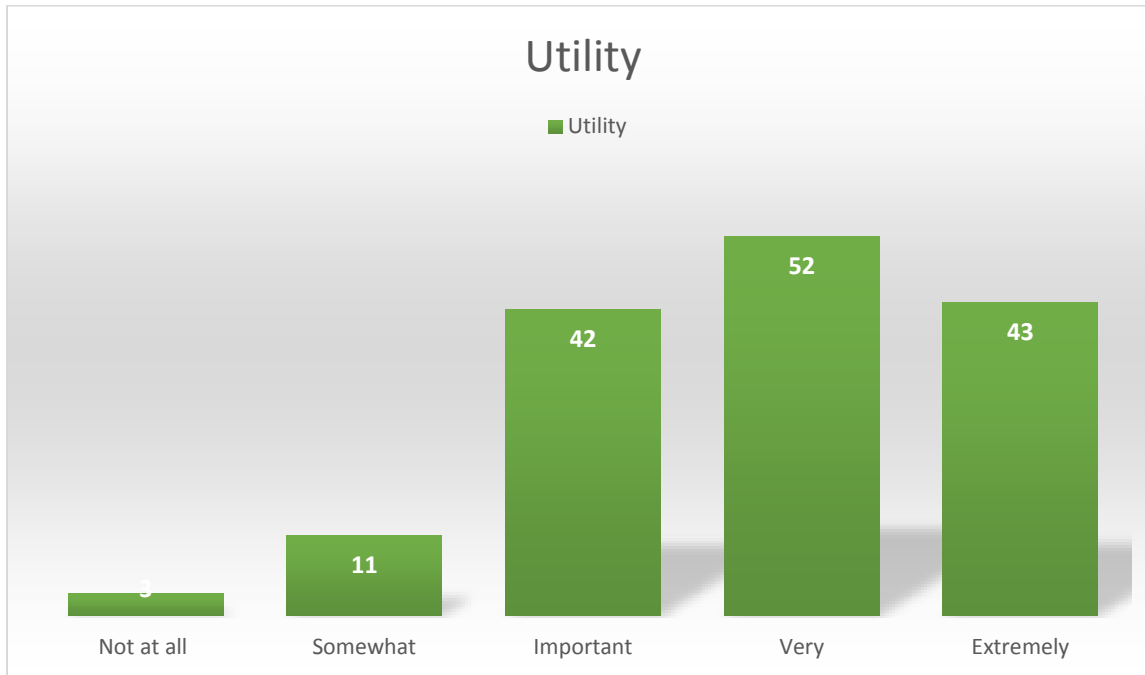

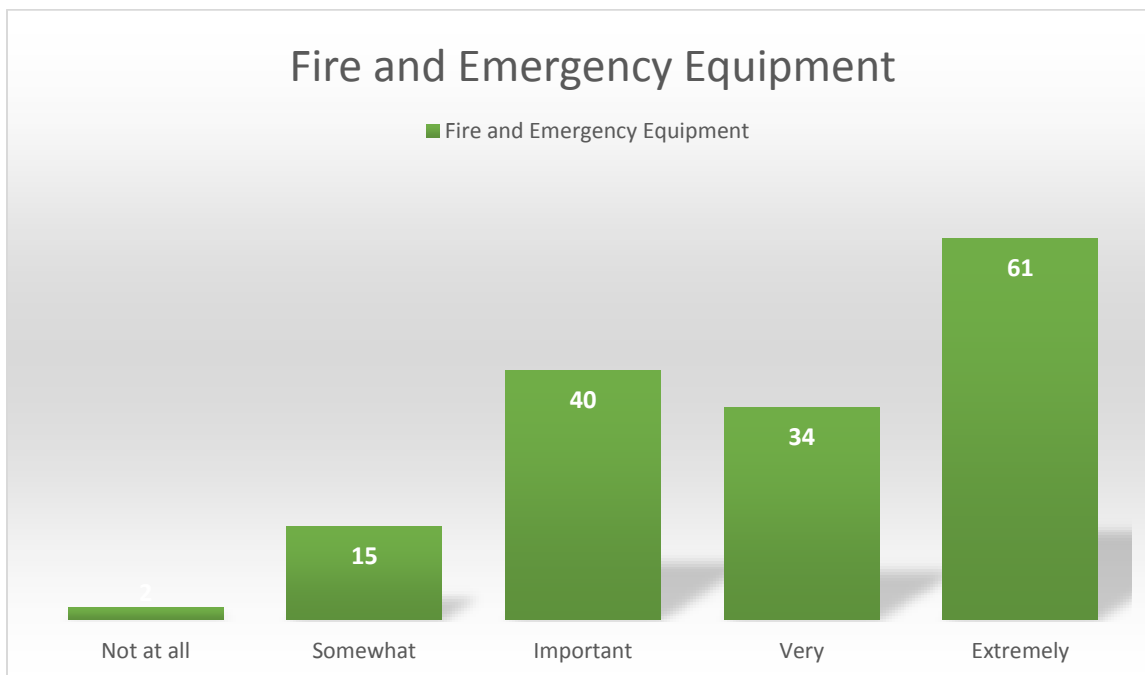

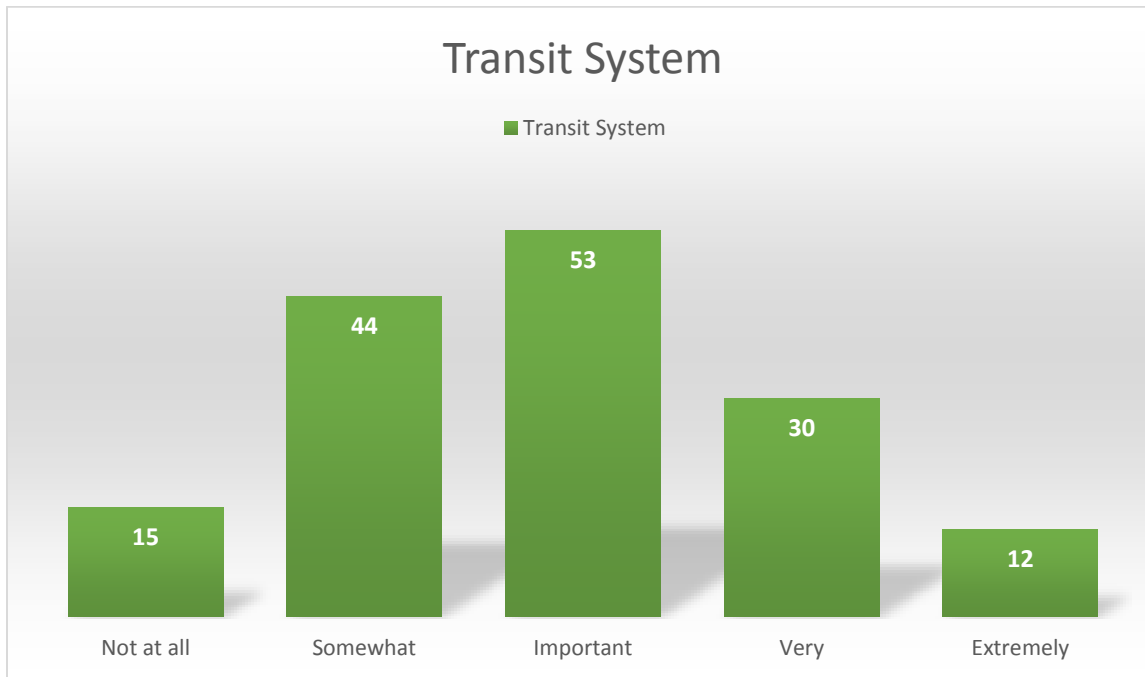

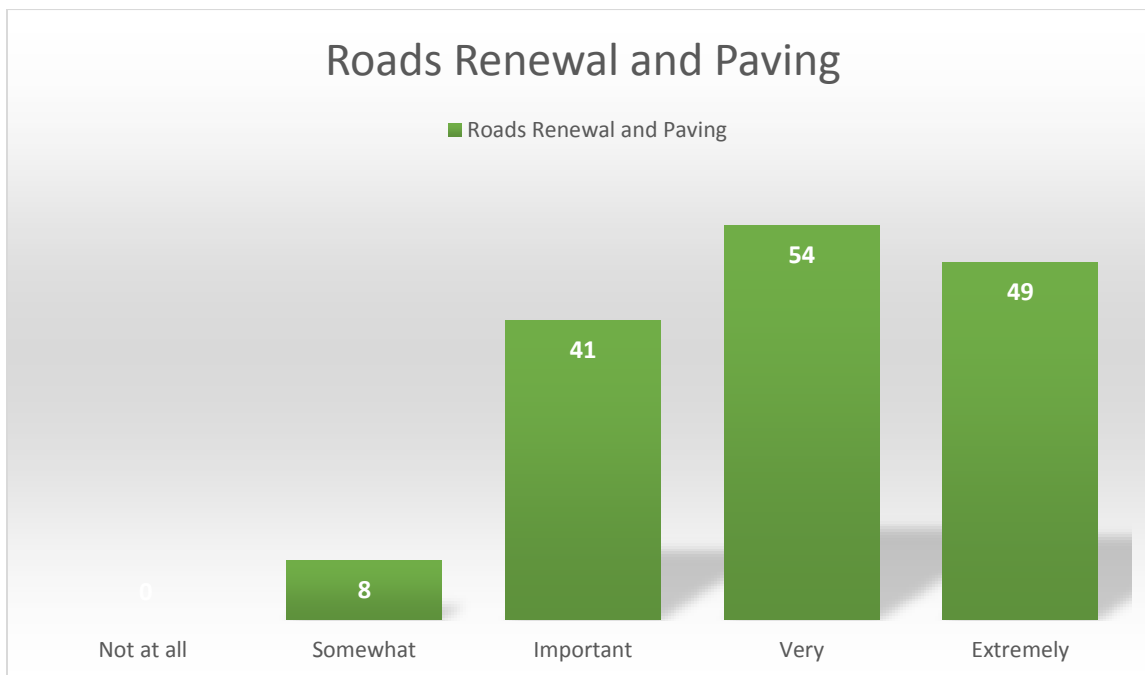

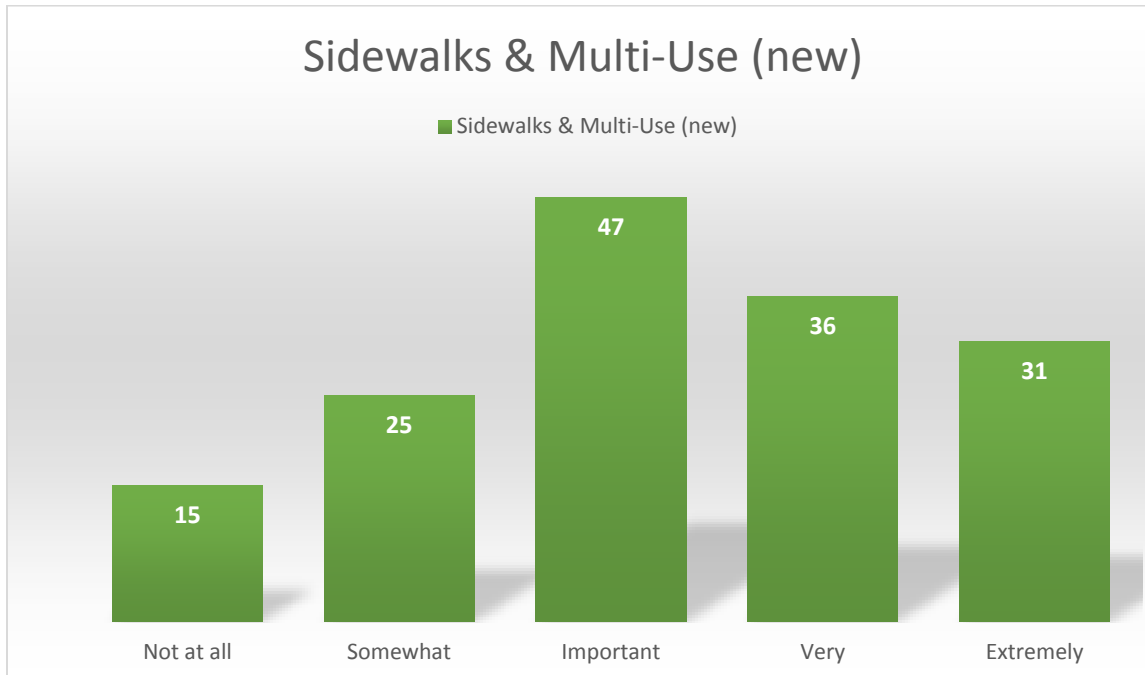

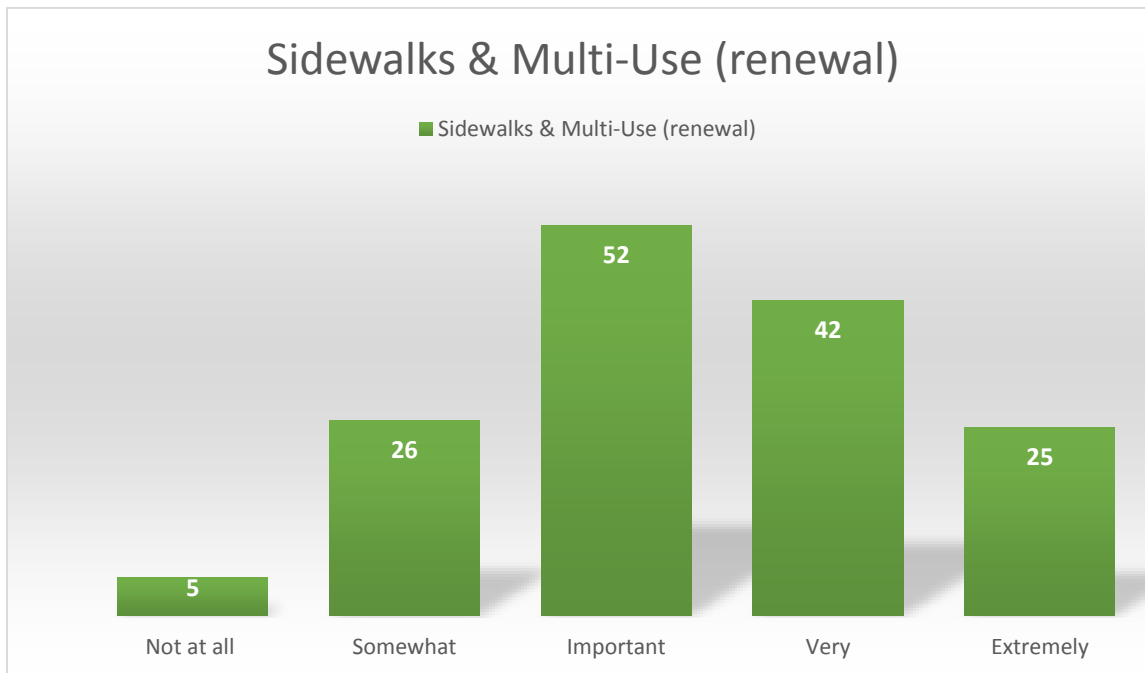

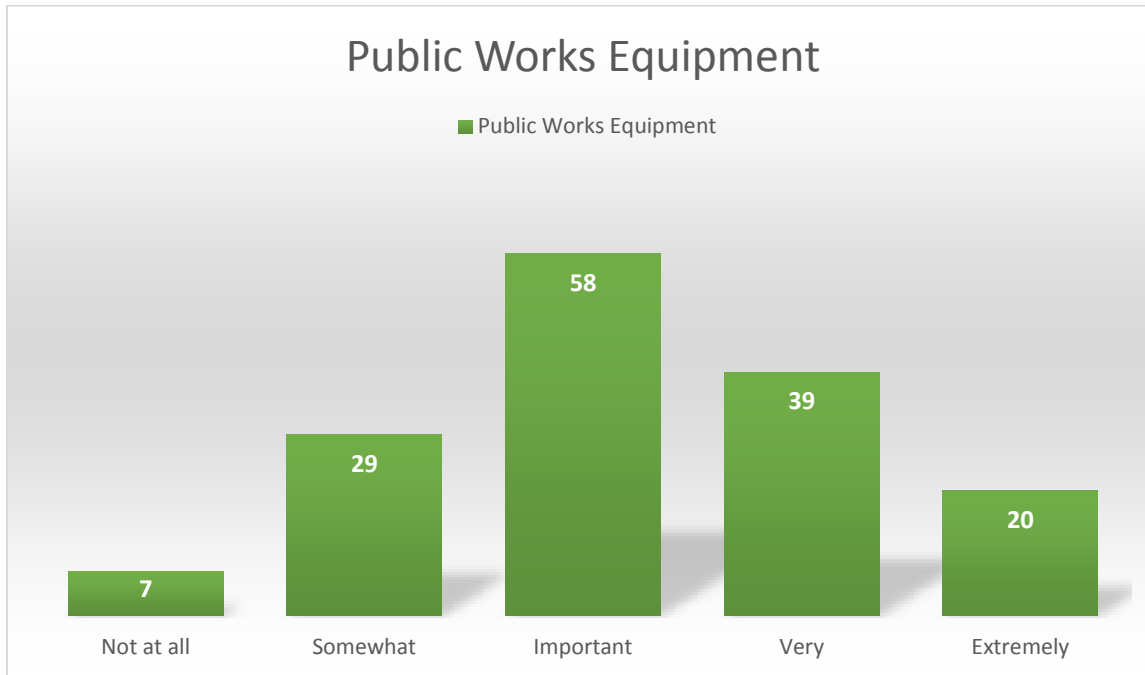

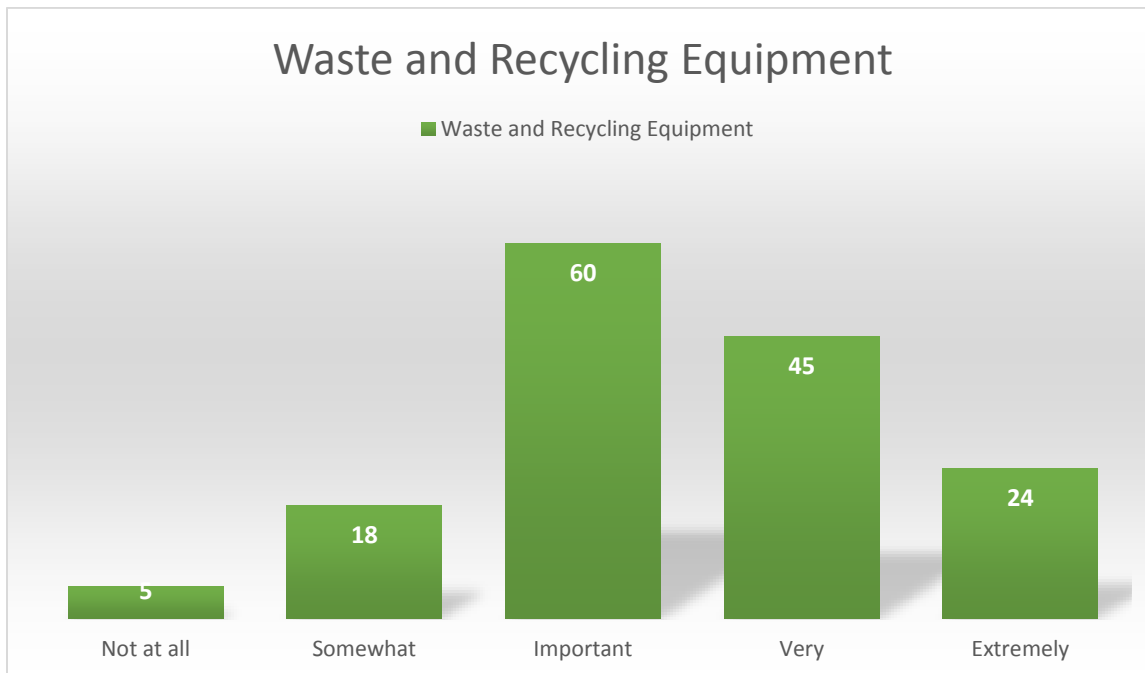

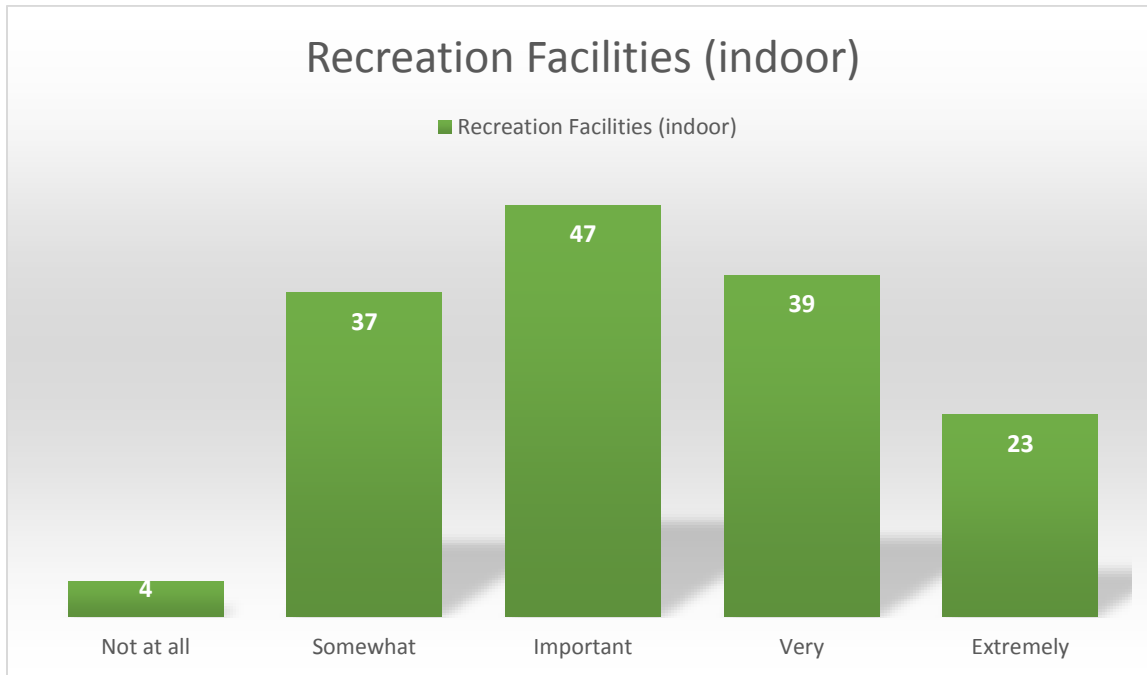

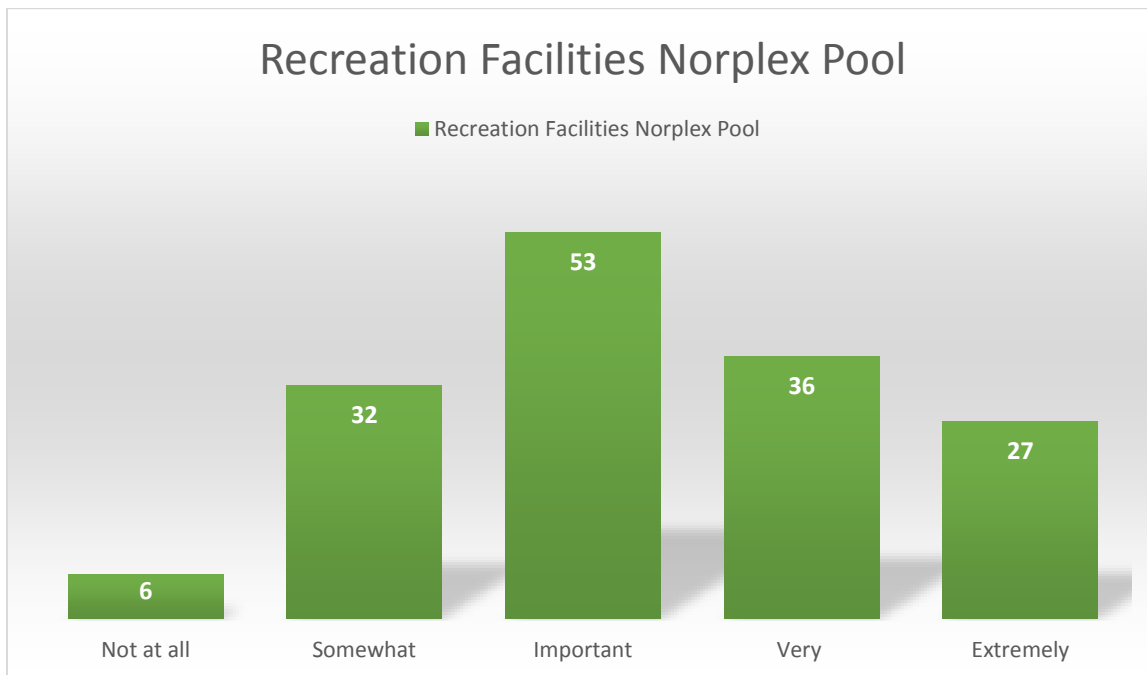

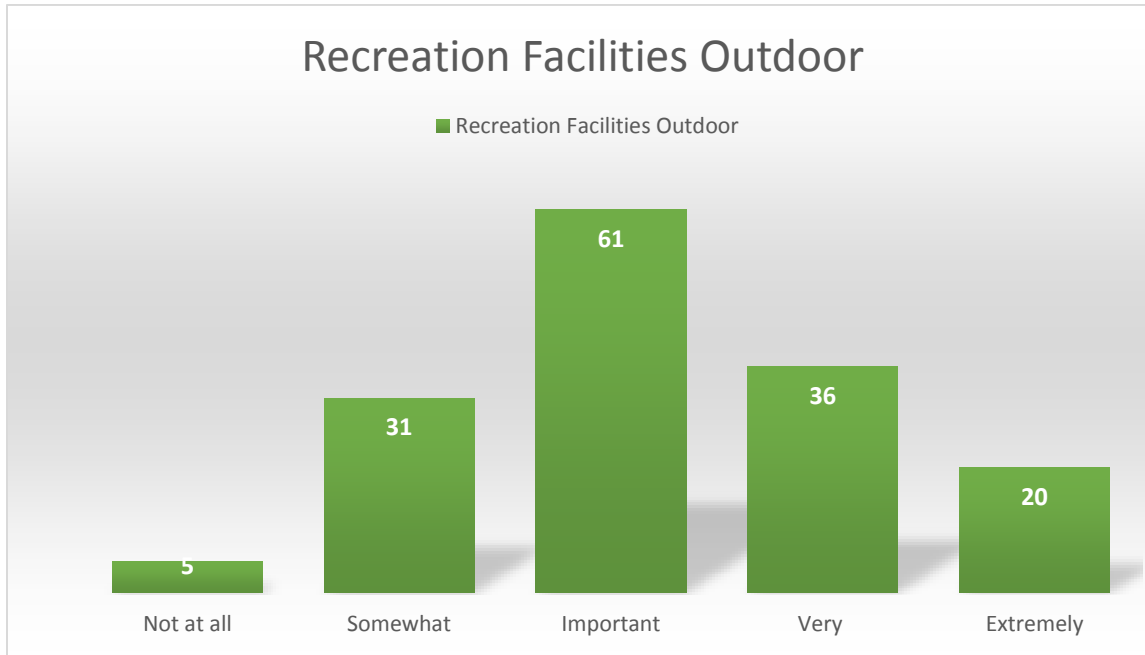

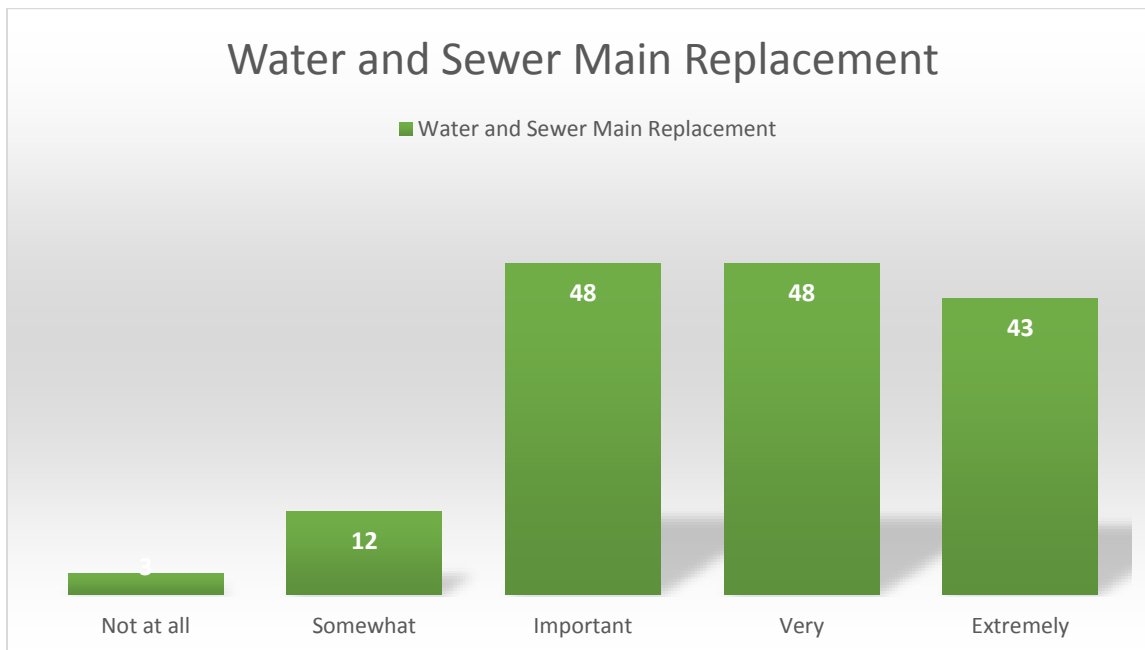

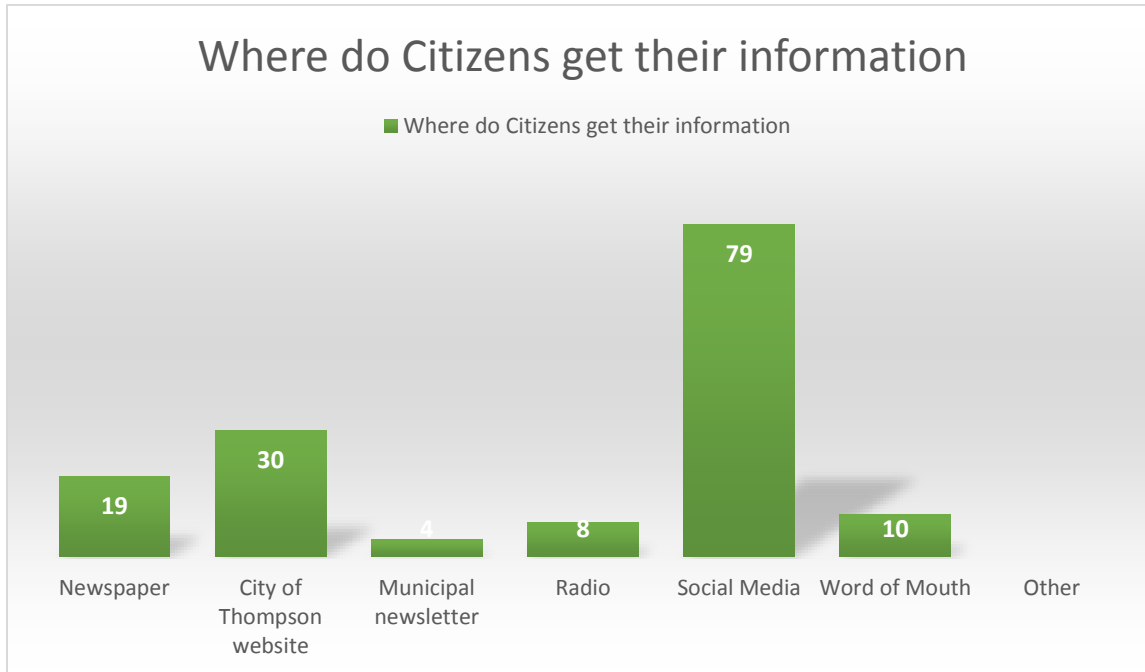

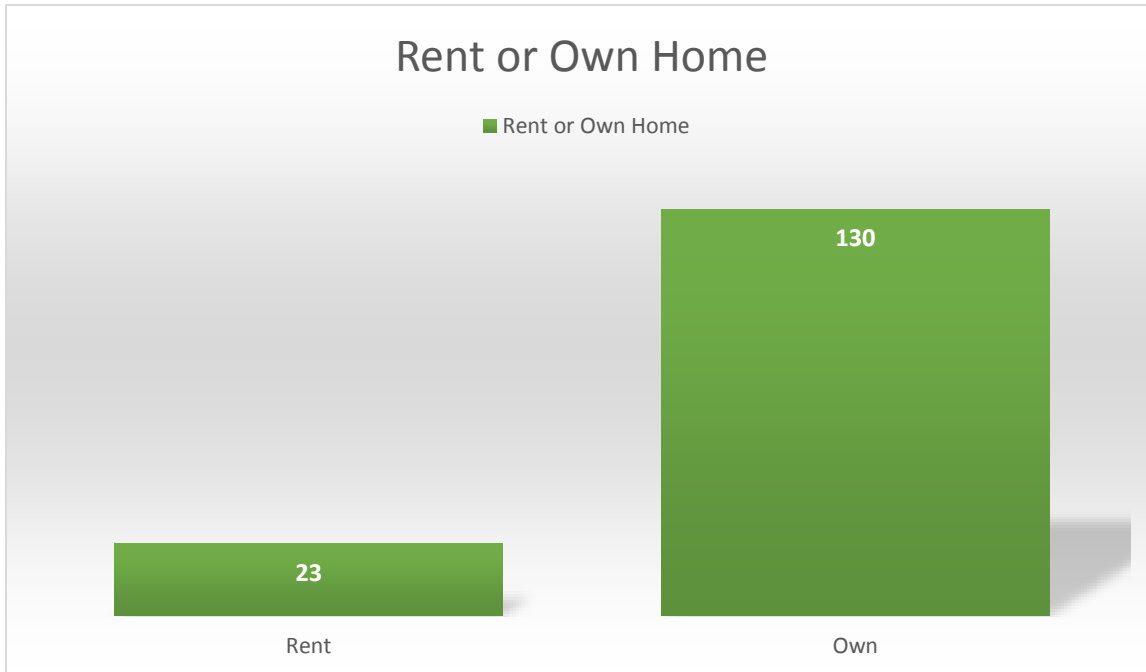

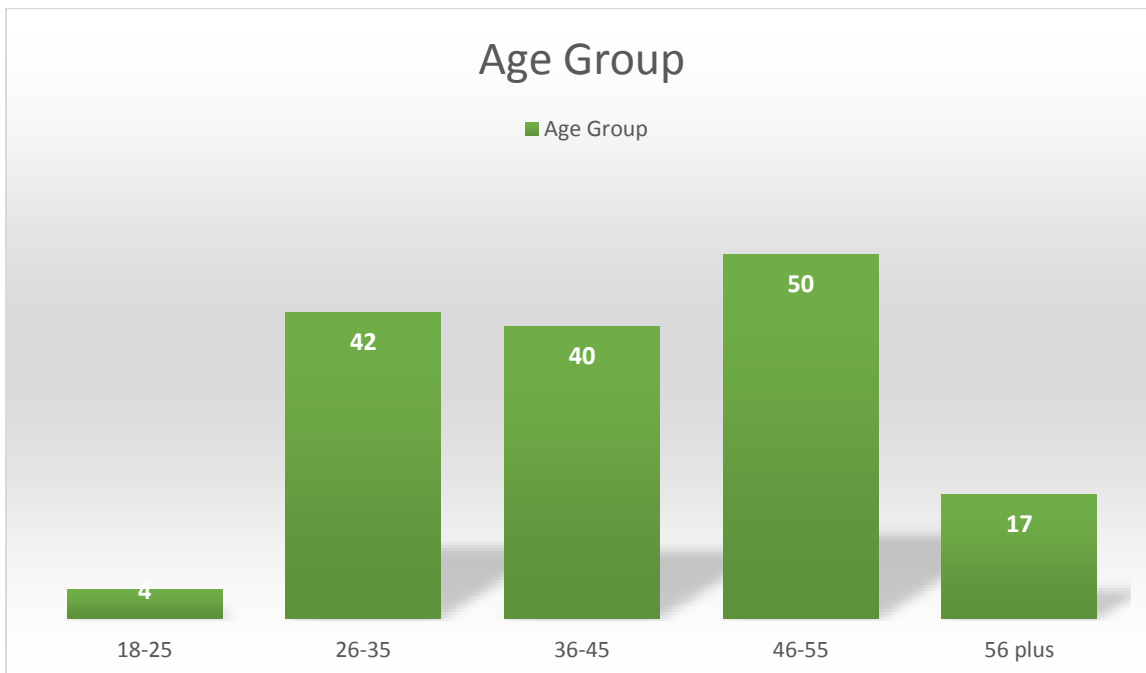
